If criminal charges are filed and the obligation is met, agree to drop charges against the individual through a rule 586 motion, The executive committee will make monthly written report detailing the current status of each recovery effort, including steps taken by the committee during the previous month, any amounts paid by the individuals and the current balance of their accounts.
