### **Proposal Title:**

**CANA Convention: Building Unity, Strengthening Recovery** 

### Purpose:

The purpose of this proposal is to establish an annual Narcotics Anonymous convention under the name **CANA** (**Central Area of Narcotics Anonymous**). This event will serve as a spiritual gathering of recovering addicts to celebrate recovery, build unity, and promote long-term service commitment within the Central Area.

### **Mission Statement:**

To carry the message of recovery to the addict who still suffers by creating a welcoming, spiritually uplifting convention experience that unites our area in purpose, service, and fellowship.

### **Justification and Need:**

- Our area has a strong and growing recovery community, but currently lacks a major unifying event such as a convention.
- Many members travel long distances to attend other area conventions. Hosting our own will make the experience more accessible.
- Conventions are proven to inspire service, foster unity, and help raise awareness and funds for our Area's efforts.

• This convention will provide a safe space for newcomers and long-timers alike to celebrate their recovery, experience fellowship, and hear powerful messages of hope.

### Proposed Name: Freedom in Unity or We Do Recover

**CANA Convention** (Central Area of Narcotics Anonymous Convention)

### Goals:

- 1. To host the first CANA Convention within the next 12–18 months.
- 2. To establish a **Convention Planning Committee** under Area supervision, with subcommittees (e.g., Program, Hospitality, Fundraising, Merchandise, Registration, etc.).
- 3. To create a **budget and fundraising plan** that supports a self-supporting event without diverting funds from regular area operations.
- 4. To select a suitable venue that is accessible, affordable, and meets the needs of our fellowship.
- 5. To remain spiritually grounded and aligned with the 12 Traditions and 12 Concepts of NA Service.

### **Action Plan:**


- Request approval from Area to form a CANA Convention Planning Committee.
- Nominate and elect trusted servants for Chair, Vice Chair, Treasurer, Secretary, and Subcommittee Coordinators.
- Develop a timeline and report monthly progress at Area Service Committee (ASC) meetings.
- Host fundraisers and begin outreach to other areas and regions for support and participation.

• Submit all financials, contracts, and major decisions to Area for approval to maintain transparency and accountability.

By establishing a CANA Convention, we create an opportunity to uplift our local fellowship, encourage service, and strengthen our collective recovery. With Area's support, we can make this vision a reality—one addict helping another through unity, service, and love.
